Commander-in-Chief's Message

On January 17, I attended a special event at the Union League of Philadelphia in which the PA Commandery unveiled a restored 134-year-old banner gifted by Original Companion Prince Philippe of Orléans, Count of Paris. The conservation effort was the brainchild of Past Commander-in-Chief Joseph Coleman. Please see page four herein for details.

In February I attended two banquets commemorating the 215th anniversary of President Abraham Lincoln's birth. On February 2 the PA Commandery held its Lincoln banquet at Radnor Hunt in Malvern. On February 11 the DC Commandery held its annual Lincoln dinner in Alexandria. The next day I presented a wreath on behalf of the Order at the 102nd Lincoln Memorial Birthday Commemoration. We should never take for granted the importance of participating in these events because one of our most important duties as Companions and Dames is honoring the memories of those men and women who courageously defended the unity and indivisibility of our nation during the Civil War. It has been said that true memory lay not in a pile of dead stones but in the living hearts of the people. More than ever our nation needs to be reminded of the heroic and patriotic virtues embodied by our predecessors. Every commandery, as part of its public outreach, should prioritize memorial events in line with this mission. To that end I encourage



you to make plans to join me in Springfield, Illinois, on Saturday, April 13 for the 68th Annual Lincoln Tomb Ceremony, commemorating the anniversary of President Lincoln's death. See page eleven for more information.

If I don't see you in Springfield, I hope you will attend the 2024 National Congress on October 11 and 12 at Pamplin Historical Park, located 30 miles south of Richmond. I am grateful to the Virginia Commandery for hosting this year's annual event. Details and registration instructions will be forthcoming.

Comte de Paris


A treasured artifact from the original MOLLUS headquarters and subsequent Civil War Library and Museum at 1805 Pine Street in Philadelphia returned in all of its grandeur to Philadelphia on January 17. Through the efforts of the Pennsylvania Commandery, the Comte de Paris banner, which was displayed at 1805 Pine Street from 1890 until the museum's closure in 2008, was retrieved from storage in Gettysburg and then conserved, framed and donated to the Union League in Philadelphia to be permanently displayed on the second floor at the top of the grand staircase. Matt Dupee, former PA Commander and current Judge Advocate-in-Chief most graciously provide the funds for the project.

The unveiling followed a presentation by Prof. Allen C. Guelzo entitled A War for the World: The Civil War and its Place in World History which led perfectly into the role of the Comte de Paris and his participation as a Captain on Gen. McClellan's staff in the Army of the Potomac. The Comte became a member of the Pennsylvania Commandery in 1880 and presented the banner to the Commandery in a 1890 return visit to Philadelphia. *

The Virginia Commandery is pleased to be hosting the 2024 Annual Meetings of the Military Order Of The Loyal Legion and the Dames of The Loyal Legion on October 11 and 12, 2024. The location for our meetings and meals, and for special tours, **Pamplin Historical Park and the National Museum of The Civil War Soldier** located on I-85 just south of Petersburg in Dinwiddie County, Virginia. This outstanding site contains one of the finest Civil War interpretive museums anywhere, and also has on its grounds well-preserved earthworks and other reminders of the breakthrough of Union forces there on the morning of April 2, 1865, that led directly to the fall of Petersburg and Richmond.

Of course, central Virginia is a prime destination for Civil War Battlefields, museums and other attractions including the nearby Petersburg National Battlefield, the Siege Museum of Petersburg, and Richmond National Battlefield Park. Feel free to come early, stay late, and enjoy all the area has to offer.

Thomas Jefferson Nill, Insignia No. 2127

Thomas Jefferson Nill was born on September 26, 1836 at Waynesboro, Pennsylvania to John and Mary Patterson Nill. He was educated in the schools of Carlisle and Lancaster. In his adulthood, he began studying law with his uncle who was a judge and was admitted to the Franklin County Bar on October 31, 1858. After being admitted to the bar, he began a law firm called Kennedy & Nill. In 1862, he dissolved his law firm and enlisted in Company E, 126th Pennsylvania Infantry. On August 10, 1862, he was elected 2nd Lieutenant of Co. E. Five days later, he was elected 1st Lieutenant and Quartermaster of the Regiment. On August 15, 1862, the regiment was ordered to the front. Unfortunately, it arrived at Antietam too late to take part in the fighting there. However, while encamped on the battlefield, the 126th, along with Lieutenant Nill were reviewed by President Lincoln and received their colors.



Three months later, Lieutenant Nill and the 126th took part in the Battle of Fredericksburg. The regiment was one of the regiments that charged Marye's Heights and lost 27 killed, 50 wounded, and 3 missing.

The next battle Nill took part in was the Battle of Chancellorsville. On May 3, 1863, while on the right wing of the Union Army, the 126th came under Confederate attack. The regiment fought for two hours. With ammunition running low, the 126th Regiment retreated to the protection of artillery. They lost 9 killed, 49 wounded and 11 captured.

After the Battle of Chancellorsville, Nill and the Regiment were ordered back to Harrisburg, where they were mustered out on May 20, 1863. After his discharge from the Army, Nill went to Hagerstown, Maryland where he became involved in the retail and grocery business. On December 24, 1867, Nill married Miss Elizabeth Johnston McLanahan. This marriage was blessed with two daughters, Mary and Sidney. In 1868, he put in a claim to the State of Pennsylvania for property he lost during the burning of Chambersburg in 1864. One of the things he lost in the burning was his law library.

In 1872, Nill became an agent for the Cumberland Valley Railroad Company in Hagerstown. Fortunately, not long afterwards he was able to get transferred to Greencastle, PA, where he was living. He also became Vice President and a Director of the First National Bank of Greencastle.

In December of 1880, apparently wanting to be reunited with his fellow officer veterans, former 1st Lieutenant Nill applied for membership in the MOLLUS Pennsylvania Commandery. He was sponsored for membership by Original Companions, Lt. Col. Benjamin F. Winger, 1st Lt. Florence W. Grugan, and 1st. Lt. Edward D. Loud. Nill was elected a Companion of the First Class in the Pennsylvania Commandery on January 5, 1881. He was assigned Insignia No. 2127.

In the 1890's, Nill began to become very active in the activities of the 126th Pennsylvania Regimental Association. In 1891, he was on the Transportation Committee of the Reunion which took place at Mont Alto Park. He was also on the Executive Committee of the Regimental Association. In 1898, he was put on the Committee on Orators and Program. In 1899, Nill took part in the celebrations for the 35th Anniversary of the burning of Chambersburg. He was one of the people still alive who had a business in Chambersburg at the time of the burning.

In 1903, Thomas Nill retired, but decided to remain a Director of the First National Bank of Greencastle. On April 13, 1904, he applied for a veterans' pension, and was awarded one. Unfortunately, on April 29, 1906, Companion Nill died of kidney disease and was buried in Cedar Hill Cemetery in Greencastle.

In addition to MOLLUS, Companion Nill was also a Comrade of the GAR. *

Colonel George G. Briggs 4004 Michigan Commandery

George G. Briggs was born On January 24, 1838 in Wayne County, Michigan. His Father, Nathan Briggs, was a native of Massachusetts and his mother was Hannah Carpenter, a native of Pennsylvania and of Quaker Stock. Nathan and Hannah came to Michigan in about 1835. They settled in Wayne County and then moved to Sturgis in Saint Joseph County where Nathan engaged in the Mercantile Trade until his death a few years later. Nathan and Hannah had four sons, with George being the oldest. After his father's death the family moved to Battle Creek, Michigan where George attended public school until he was 14 years old. George then entered in a mercantile House in Battle Creek, Michigan, where he remained in the capacity of a clerk for three years.

George also spent six months at Olivet College, then left to accept a position of Book Keeper in the Principal Mercantile House of Galesburg, Illinois. After serving as a Book Keeper, George resigned and returned to Battle Creek and purchased an interest in the firm Averell and Manchester. George continued this connection under the name of Averell & Manchester, and continued this connection under the name of Averell Briggs & Company In1862, George disposed of his business interest and immediately commenced active participation to raise troops for service in the Union Army. For the next four years he dedicated his time and energy in raising troops for the Union cause.




Through his efforts, a Cavalry Company consisting largely of his friends and acquaintances from the Battle Creek area was formed and George Briggs was appointed a 1st Lieutenant and became part of the 7th Michigan Cavalry. Before he left for the front, George Briggs made a farewell visit to his friends in Galesburg, Illinois. Here he was presented a sword as an expression in which he was held in esteem. On September 13, 1862, George as a 1st Lieutenant in the 7th Michigan Cavalry entered into service. On July 1, 1863, George was promoted to Adjutant. He was again promoted to Captain on March 22, 1864. Further he was next promoted to Major on May 19,1864 and Lieutenant Colonel on October 2, 1864. On May 26, 1865 he was appointed to Colonel. The 7th Michigan Cavalry was a well-known Regiment in which the names of Custer, Litchfield, Mann and Sheridan, are well-known. Colonel George G. Briggs has the honor of having been the last Colonel to command the 7th.

At the reunion of the 7th Michigan Cavalry Association in 1901, Colonel Briggs stated in his departing words: "Exhausted nature sent us to our blankets and we slept that night with thankful hearts that one more day of our three years, or during the war, was over. In thus taking leave of the Command, I bid it an affectionate good-night, and to you its survivors, I extend the greeting of a cordial good morning." **
